# **Launch Of Mighty Minds 2011**

Students will be tested with general knowledge questions, as well as learn to put the fun and excitement back into learning Maths and Science, through the use of cold, hard facts, and creativity.

The RHB-Star Mighty Minds is also held in support of the Government's initiative in encouraging secondary students to expand and develop their knowledge specifically in Maths and Science. The general questions are incorporated into the
