Revision of RHB Loyalty Programme and RHB Credit Card/-i Product Terms and Conditions

17 March 2025

Dear Valued Customers,

We would like to inform you of the following changes effective 9 April 2025.

1. Segregation of RHB Loyalty Points

- Existing RHB Loyalty Points earned from *non-Credit Card/-i transactions will be transferred to the new RHB Loyalty *Plus* Points.
- All available existing RHB Loyalty Points earned from RHB Credit Card/-i as at 8 April 2025 will be equally split (50% each) into Loyalty *Plus* and Loyalty points.
