Eligibility	Clause 3 The Campaign is open to all existing RHB Credit Card/-i (hereinafter referred to as the " Participating Product ") holder, both residents and non-residents, including of RHB Banking Group staff (collectively, " Eligible Participants ").	Clause 3 The Campaign is open to all existing RHB customers both residents and non-residents, including of RHB Banking Group non-sales staff (collectively, " Eligible Participants ").

To participate into the Campaign, the Eligible Participants may refer his/her friend(s)/family ("Referee") by sharing the referral code or links ("Referral Link") generated via RHB corporate website to the Referee to apply the RHB Credit Card/-i via the Referral Link before the name of Referee is registered in the system as RHB Customer during the Campaign Period. 8. Referee must submit and complete their application for an eligible RHB Credit Card within the Campaign Period on or before 31 October 2026 by completing an online RHB Credit Card application form and uploading all required supporting documents to the Bank via the unique Referral Link. 10. All applications must be approved 30 November 2026 to be considered as successful referral. 11. Eligible Participants is open to RHB staff, however applications for credit cards made by RHB staff are not eligible under this Campaign.	6. Referee must submit and complete their application for an eligible RHB Credit Card within the Campaign Period on or before 31 December 2026 by completing an online RHB Credit Card application form and uploading all required supporting documents to the Bank via the unique Referral Link. 10. All applications must be approved 31 January 2027 to be considered as successful referral. 11. Eligible Participants is open to RHB non-sales staff, however applications for credit cards made by RHB staff are not eligible under this Campaign.
