ASSIGNMENT OF PROCEEDS UNDER LETTER OF CREDIT (AOPLC)

PRODUCT INFORMATION

Assignment of Proceeds under Letter of Credit (AoPLC) is a service offered to Letter of Credit (LC) beneficiaries to assign their LC proceeds to the ultimate supplier. A request for an assignment of proceeds would take place when the beneficiary of the LC (i.e. a middleman in a trade transaction) is required to provide payment assurance to its ultimate supplier. This is an alternative to having the LC transferred or having to issue a back to back LC to the ultimate supplier.

The Bank acts on the instruction of the beneficiary (through Notice of Assignment of Proceeds under LC) to facilitate the disbursement of proceeds to the assignee upon receipt of export proceeds from the LC issuing bank. The Bank does not provide any payment undertaking and there is no requirement for the setting up of trade facility. A Letter of Notification is issued by the Bank to notify the assignee of the assignment.

FEES, EXPENSES AND TAXES

For the avoidance of doubt, the Customer shall bear all professional fees, taxes (including but not limited to service tax or Goods and Services Tax (GST)), and out-of-pocket expenses incurred and any other fees, expenses or recourse in respect of this product.

PENYERAHAN HAK PENERIMAAN DI BAWAH SURAT KREDIT (PPSK)

MAKLUMAT PRODUK

Penyerahan Hak Penerimaan di bawah Surat Kredit (PPSK) merupakan perkhidmatan yang ditawarkan kepada benefisiari Surat Kredit (SK) untuk menyerah hak penerimaan SK mereka kepada pembekal yang paling utama. Permintaan bagi penyerahan hak penerimaan akan dijalankan apabila benefisiari SK (iaitu orang tengah dalam urusan niaga perdagangan) diperlukan untuk menyediakan jaminan bayaran kepada pembekal yang paling utama. Ini sebagai satu cara alternatif untuk memindah milik SK atau untuk mengeluarkan SK Sandar-menyandar kepada pembekal yang paling utama.
