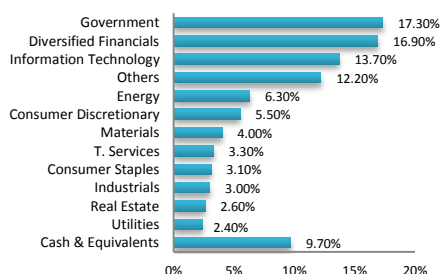

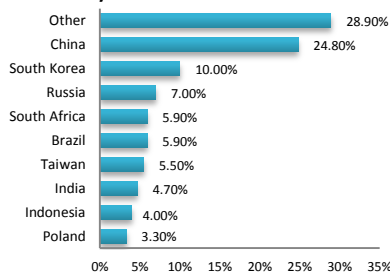

MANAGER'S COMMENTS**MARKET OUTLOOK**

Overall the Target Fund Manager remains constructive on Emerging market (EM) assets due to the positive global growth picture. However, given the scope for higher volatility, with uncertainty over inflation and the path of interest rates, and increasing idiosyncratic risks in many markets, the Target Fund Manager believes investors need to become increasingly selective.
