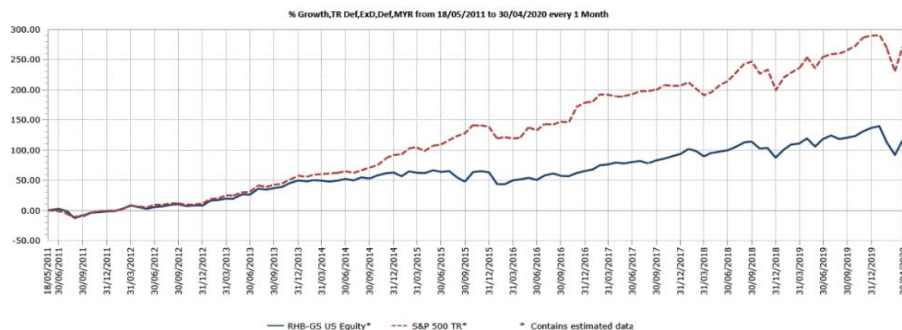

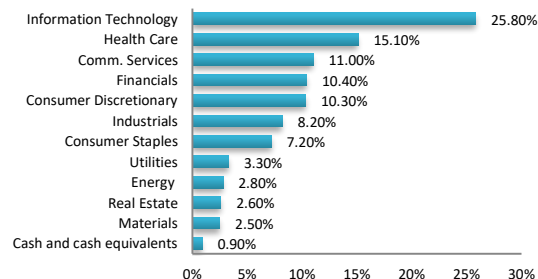

MANAGER'S COMMENTS

MARKET REVIEW

The S&P 500 index increased in April, returning 12.82% (total returns, in USD). While concerns of the coronavirus and challenged economic data continued in April, equity markets showed considerable strength, supported by expansionary monetary and fiscal policy. In March, the unemployment rate jumped to 4.4% in the largest month-over-month rate increase since January 1975 with 7.1 million unemployed. US GDP for the first quarter of 2020 fell by 4.8%. However, the \$2.3 trillion CARES Act helped ease market concerns as consumers continued receiving payments from the government. Additionally, the Payment Protection Program, which gives forgivable loans to small businesses that agree to keep employees on payroll, has helped provide support for the economy. The best performing sectors were Energy, Consumer Discretionary, and Materials while the worst performing sectors were Utilities, Consumer Staples, and Industrials.

Based on the fund's portfolio returns as at 10 April 2020, the Volatility Factor (VF) for this fund is 14.5 and is classified as "Very High". (source: Lipper) "Very High" includes funds with VF that are more than 11.1 (source: Lipper). The VF means there is a possibility for the fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The fund's portfolio may have changed since this date and there is no guarantee that the fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC. The VC referred to was dated 31 December 2019 which is calculated once every six months and is valid until its next calculation date, i.e. 30 June 2020.
