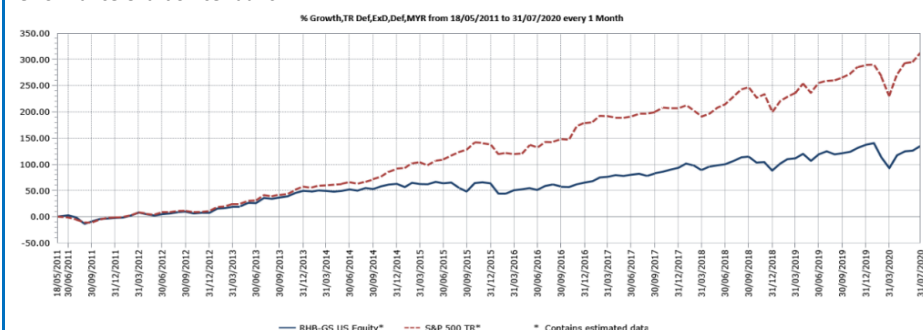

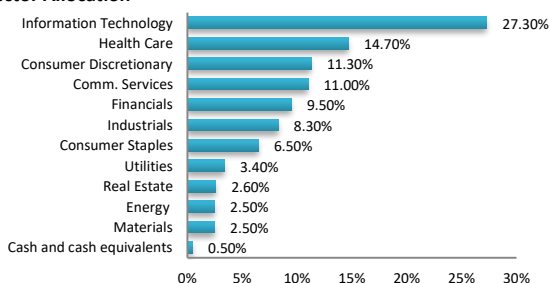

### MANAGER'S COMMENTS

#### MARKET REVIEW

The S&P 500 index increased in July, returning 5.64% (total return, in USD). Equity markets were supported by the release of positive test data from multiple coronavirus vaccine candidates, despite headwinds caused by rising cases in various hotspots around the country. Stocks also benefitted from the proposal of a \$1 trillion coronavirus relief bill and a strong earnings season, which showed sequential improvement in demand and operational trends. Although there were fears about slowing high-frequency economic indicators during the month, the July unemployment rate was reported better than expected at 10.2% with non-farm payrolls increasing 1.76 million. The best performing sectors were Consumer Discretionary, Utilities, and Materials while the worst performing sectors were Energy, Financials, and Real Estate.

Based on the fund's portfolio returns as at 14 July 2020, the Volatility Factor (VF) for this fund is 16.2 and is classified as "Very High". (source: Lipper) "Very High" includes funds with VF that are more than 15.4 (source: Lipper). The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
