





MANAGER'S COMMENTS

MARKET ENVIRONMENT

Asian high yield market posted gains for the fifth consecutive month in August. Credit spreads continued to tighten, retracing by more than 85% from record March widening. Investors have continued to disregard the news related to spike in the US-China tensions and focused more on the 'first in- first out' version of China story and progress in vaccine development. Meanwhile, investor's search for yield amid a scenario of loose monetary policies by the central banks has continued to lift the market. In key developments, the US government continued to expand its sanction lists on Chinese corporates during the month. However, both the countries have been still complying to the phase one trade deal. On the economic front, data continued to show recovery with China's industrial profit registering a third consecutive month of annual growth while the service production index gained further ground in July. Exports rose and beat estimates in July. Purchasing managers' index data showed that manufacturing activities expanded in August while fixed asset investment over the January-July period was in line with expectations. China's property sales remained resilient in July with new home prices increasing by 4.8% year-on-year. That said, discussions are being held between authorities to curb leverage in the property sector. On the technical front, issuances slowed during the month in line with weak seasonality due to the interim results.

TARGET FUND POSITIONING

Going forward, the Target Fund Manager holds a cautiously constructive view on the Asian High Yield market. Post COVID-19 outbreak, China is expected to recover relatively faster than the rest of world. However, given the damage caused by the pandemic to the global economic activity - a V-shaped recovery is unlikely. Moreover, risk from the second wave of virus outbreak cannot be ruled out. Other factors to watch out include the progress in vaccine development, presidential elections in the US and whether the tensions between the US and China would dial back progress on the phase one trade deal. That said, downside to risk assets is likely to remain contained since China has the room to ramp up stimuli in monetary and fiscal terms. Meanwhile, stimulus measures are likely to continue in other Asian regions. Despite a strong recovery in valuations, pockets of investment opportunities exist subject to careful credit selection. Technicals are likely to remain supportive as investors explore for yield amid easing bias of central banks. Target Fund Managers expect defaults to remain around 3-5% for 2020 - higher as compared to 1-2% of 2019. The Target Fund stays moderately overweight credit beta given current valuations remain attractive relative to other regions and global relative macroeconomic situation justify such positioning - offering attractive potential total return driven by high income over next 12-15 months. The Target Fund Manager will continue to selectively and passively add risk while managing overall liquidity. The Target Fund has 15-20% market weight in short dated (<1year)/near-term callable bonds and cash to ensure a robust liquidity profile and maintain high natural income. In terms of duration, the Target Fund is overweight.
