





### MANAGER'S COMMENTS

#### MARKET OUTLOOK AND STRATEGY

Looking ahead, the Target Fund Manager prefers to stay slightly positive in Asia credit bonds with a focus on defensive carry. As the economy prepares itself to contain further coronavirus widespread during this cold winter, near term market headwind and volatility should ease somewhat as driven largely by the positive vaccine news. From now to early months of 2021, all eyes will be on the change in US political powers and the intended plans under the new Biden administration. Unilateral or Multilateral? Policies affecting global economies will be scrutinized as any wrong or misfootsteps will aggravate damages on the already weakened global economies. That said, China's new 5-year plan towards achieving stable quality growth and China's fast economic recovery from the coronavirus pandemic will likely help to reduce any excessive volatility and provide good support for Asia credit market in the medium term. Meanwhile, the unwavering determination of global central banks to provide whatever necessary easing measures will keep the probability of a significant market correction distanced. Again, encountering any sell-off will be the window of opportunity for investors to gather accretive assets.

Overall, staying calm and ride through this volatile period had indeed earned investors a decent total return and this reward will likely continue. Enormous liquidity pumped into the global system, the anchored Asian demand and manageable supply will remain as favourable technical contributor towards the returns for Asia Credit asset. The Target Fund Manager continues to reiterate the importance of credit differentiation and staying invested. Scrutinize issuers' profile for adequacy, assessing their abilities to cope with the impacts during this challenging viral period and to evaluate the new potential business strategies they devised as they move ahead into the "new normal" world, remain on the Target Fund Manager's main radar screen. On the duration strategy, the Target Fund Manager will be staying broadly neutral in overall duration though they may engage in tactical duration positioning.
