





MANAGER'S COMMENTS

MARKET REVIEW AND OUTLOOK

Global equity markets rallied in June 2014. EMs caught up their underperformance at the beginning of the year and the European region lagged the developed world markets. The global economy has overcome its temporary soft patch after the fading of several exceptional factors as the very bad weather impact from beginning of the year in the US.

After a disappointingly sluggish start of the year, signs of a gradual acceleration of the world economy have grown over the past weeks. The bottoming out of macroeconomic indicators point to a reacceleration of inflation trends over coming months. The relative strength of economic data in industrialized versus developing countries continued.

However, emerging market growth data improved for the first time this year in June. The European Central Bank (ECB) announced interest rate cuts with the main refinancing rate down to 0.15%. Forward guidance states that interest rates will remain as low as today for an extended period of time. During the Q&A session, ECB President Mario Draghi confirmed that rates are unlikely to fall further from here.

With those measures the ECB delivered on all options realistically discussed before. The next major step from here would be a large bond purchasing program, which is still in the cards should inflation rates decrease from here or should stay subdued for too long.

Geopolitical tensions, a mishandled change of the monetary policy stance by the US Federal Reserve and a more severe economic slowdown in Emerging markets remain major downside risk factors for the global economy.
