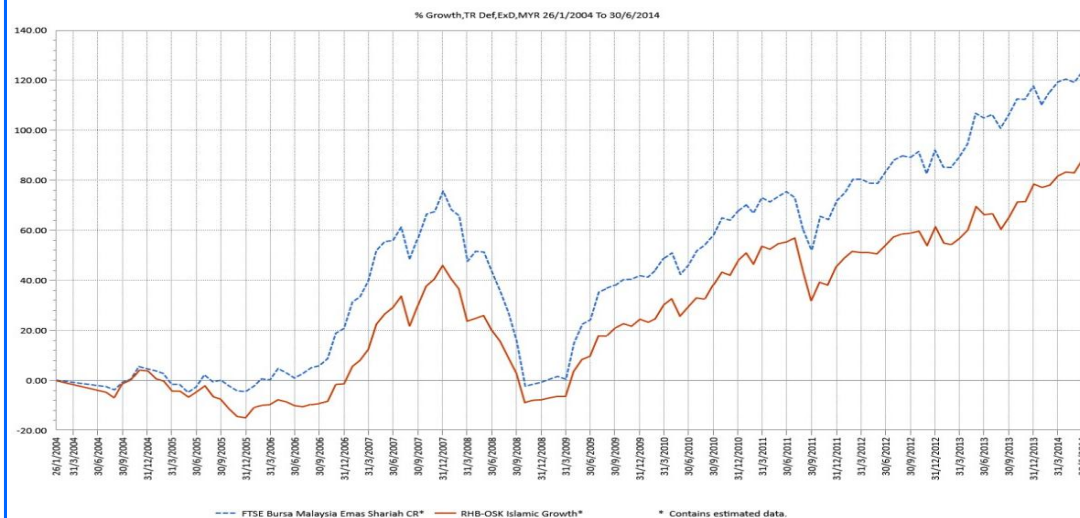

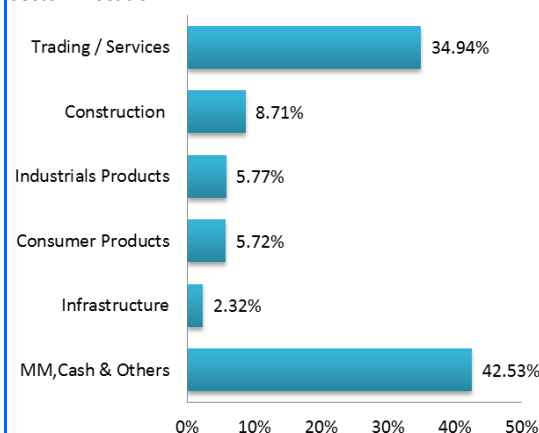

MANAGER'S COMMENTS**EQUITY MARKET REVIEW**

June was a decent month as the KLCI again squeezed out several new all-time high days. The annual Invest Malaysia event held on June 9-10 to a record attendance failed to excite the market due to lack of major announcements. Uncertainties surrounding the interest rate, weak quarterly earnings and unattractive regional valuations kept the KLCI at bay for the last few weeks. The KLCI ended the month 9pts or 0.5% higher to close at 1,882pts. The broader market marginally outperformed the KLCI as the FBM Emas gained 0.6% mom to 13,022pts. Small cap performance outperformed as the FBM Small cap gained 2.7% to 17,932pts.

MARKET OUTLOOK

KLCI saw some action in the later part of June as it rose to a new all-time high of 1,892.33. There were initial thoughts of a June-July 'World Cup' slumber but the recent performance of the KLCI as well as the movements for some of the mid-cap and small cap stocks saw the overall market breathing a bit of a 'fresh air' at this juncture. For the month of July, we are tweaking our resistance from 1,890 to 1,900-1,910. Any downside risk should be well absorbed at the 1,860-1,850 level as we do not expect to see any significant selling pressure to come in soon. Evidently, foreign and domestic investors were net buyers in the month of June (foreign: RM0.5bn, local RM0.3bn), an indication that the KLCI will be supported at the stipulated support zone in the event of any accelerated selling activities. Major risk to our assumptions will be from the uncertainties in the global geo-political environment (Iraq and Ukraine), steep capital outflows and China's economic slowdown that will have a spiralling impact on regional peers.
