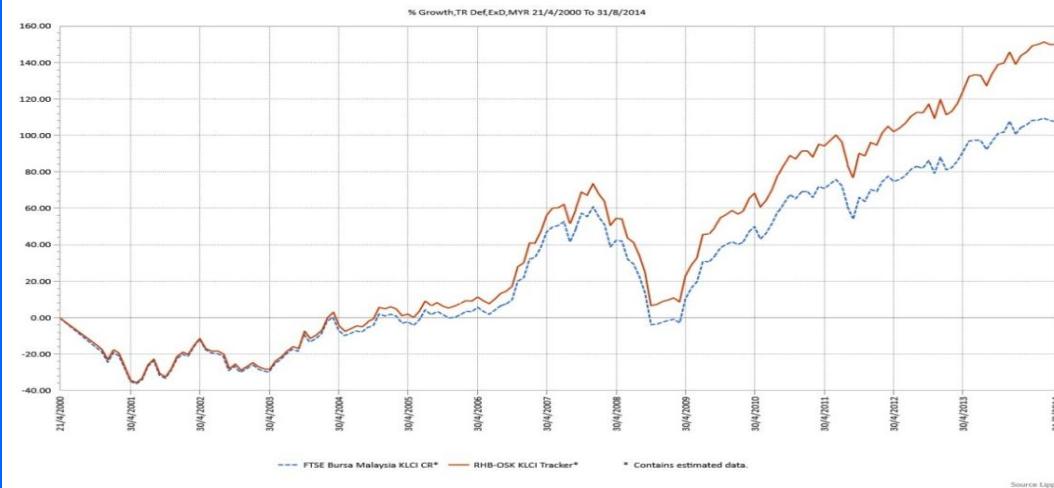

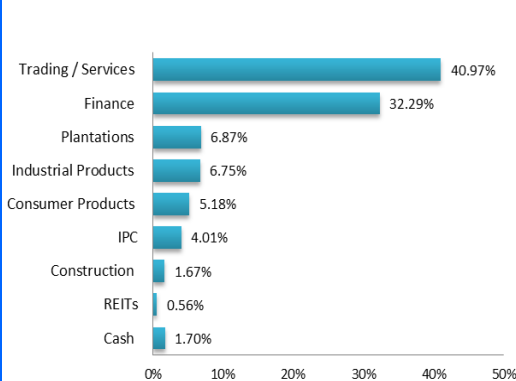

**MARKET REVIEW**

The FBM KLCI, in August 2014, down by 0.28% to close at 1,866 points. The broader market decreased with the FBM EMAS depreciating 0.69% to 12,995 while the FBM Small Cap down by 2.42% to 18,604 points.

**FUND REVIEW**

Tracker Fund's NAV/unit decreased by 0.02% compared to the FBM KLCI's down of 0.28%.

**DISCLAIMER:**

Based on the fund's portfolio returns as at 15 August 2014, the Volatility Factor (VF) for this fund is 9.4 and is classified as "Moderate". (source: Lipper) "Moderate" includes funds with VF that are above 7.9 but not more than 10.6 (source: Lipper). The VF means there is a possibility for the fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
